The Shanghai Futures Exchange's most-traded January contract for hot-rolled coil - a major downstream flat steel product - closed of Friday at 3,727 yuan (\$512) per tonne, down by 4 yuan from last Thursday's closing price.

Fastmarkets' weekly price assessment for steel plate domestic, ex-whs Eastern China was 3,760-3,800 yuan (\$516-522) per tonne on October 13, down from 3,830-3,850 yuan per tonne in the previous week - its fifth consecutive weekly decline.

A mill in northeast China lowered its offer price for medium plate by 10 per tonne to 550 per tonne, FOB China, on Tuesday, with shipment available for December.

And a mill in Inner Mongolia kept its offer price for December-shipment medium plate unchanged at \$560 per tonne FOB China, sources told Fastmarkets on Tuesday.

In Hebei province, meanwhile, a mill in Handan city was also offering the material at \$550 per tonne FOB China, and a mill in Tangshan lowered its offer price to \$555 per tonne FOB China, down from the previous \$563 per tonne.

A trader based in Hong Kong said that buyers in Southeast Asia were looking for the lowest-priced medium plate cargoes from China.

"Overall deals and inquires have increased in recent weeks due to the falling offering prices," a Zhejiang-based trader said.

A Shanghai-based trader said that medium plate export prices could be supported this week because of the the uptrend in steel futures prices and the recovery in domestic spot steel prices.

But a mill source from North China said that while trading in domestic medium plate had increased on Monday due to the higher steel futures prices, activity and prices in the export market were largely stable.

"It takes some time for export medium plate prices to follow domestic steel price movements," the source said.

# Chinese HRC prices continue to rise amid improved trading

Spot hot-rolled coil prices in China's domestic market continued to rise on Tuesday October 17, with market sentiment boosted by a solid increase in construction steel trading and increased expectations of a slowdown in flat steel production.

#### Domestic

Fastmarkets' price assessment for steel HRC domestic, ex-whs Eastern China (Shanghai) was 3,770-3,780 yuan (\$516-517) per tonne on Tuesday, up by 20-30 yuan per tonne from 3,740-3,760 yuan per tonne on Monday. The most-traded January HRC contract on the Shanghai Futures Exchange rose to the highest level so far this month at 3,793 yuan per tonne during morning trading on Tuesday before coming off to finish the trading day slightly lower than Monday's close.

A sharp increase in spot rebar trading volumes so far this week compared with last week due to better weather, coupled with expectations that losses would force mills to scale back operations, bolstered SHFE and spot HRC prices, market participants said.

Data from a local information provider shows that rebar trading volumes across 237 major trading houses in China jumped by 43.5% from last Friday to 208,200 tonnes on Monday, which marks the highest single-day increase since May.

Blast furnace operating rates at 247 steelmakers in China also dipped by 1.21 percentage points week on week to 82.2% last week, according to the data.

#### Export

Fastmarkets calculated its steel HRC index export, fob main port China at \$525 per tonne on Tuesday, unchanged from Monday.

Chinese HRC export prices were steady on Tuesday, with SHFE HRC prices still rangebound.

Export prices for 3mm SS400 HRC from small mills in northern China remained at \$510-530 per tonne FOB China on Tuesday, unchanged from Monday and from late last week according to market participants.

Large mills also kept their offers for similar cargoes unchanged week on week at \$540-550 per tonne FOB China for December delivery.

Traders, meanwhile, were offering HRC at \$525-530 per tonne CFR Vietnam for 3mm SS400 cargoes - slightly higher than late last week's traded level of \$520-523 per tonne CFR Vietnam.

Freight rates from China to Vietnam were estimated at around \$13 per tonne, market participants said.

#### Market chatter

"HRC export prices look set to stay at current levels in the short term unless exchange rates experience great volatility. Thin margins or even losses are deterring mills from lowering their offers," a trader in eastern China said.

#### Shanghai Futures Exchange

The most-traded January HRC futures contract closed at 3,766 yuan per tonne on Tuesday, down by 6 yuan per tonne from Monday's close of 3,772 yuan per tonne.

# Mexican ferrous scrap prices decline after buyers' push

#### By Felipe Peroni - Tuesday 17 October

Mexican steel scrap prices suffered their first decrease in more than two months on Tuesday October 17, with buyers trying to adjust their prices compared with scrap prices in the US.

Buyers of ferrous scrap were announcing price cuts of 100-300 pesos (\$6-17) per tonne, depending on the grade and region. It is the first price reduction since early August, interrupting a sequence of price rises.

Fastmarkets' assessment of the steel scrap No1 busheling, consumer buying price, delivered mill Bajio reached 7,100 pesos (\$395) per tonne on Tuesday, down by 100 pesos per tonne from 7,200 pesos per tonne in the previous week.

The assessment for the steel scrap cut structural/plate 3ft max, consumer buying price, delivered mill Bajio remained unchanged on Tuesday at 6,900 pesos per tonne.

Meanwhile, the weekly assessment of the steel scrap No1 busheling, consumer buying price, delivered mill Monterrey was 7,000 pesos per tonne on Tuesday, down by 150 pesos per tonne from 7,150 pesos per tonne a week earlier.

And Fastmarkets' weekly assessment of the steel scrap No1 heavy melt, consumer buying price, delivered mill Monterrey came to 6,550 pesos per tonne on Tuesday, a decrease of 100 pesos per tonne from 6,650 pesos per tonne previously.

The price decreases were motivated by a reduction in prices for plate and shredded scrap in the US in the October trade. Some market participants believed there could be an increase in imports into Mexico.

"It has been circulating information that consumers are trying to import more scrap material from the US," a source said.

Also, buyers have been bothered by the tight gap between prices of prime scrap in the US and Mexico.

Fastmarkets' steel scrap No1 busheling index, delivered Midwest mill was calculated at \$408.81 per gross ton on Tuesday October 10, down by 0.41% from \$410.50 per gross ton in September. The assessment is equivalent to \$402.35 per tonne, compared with about \$395 per tonne delivered mill Bajio.

In the US, sellers have been showing cautious optimism about the November trade, which will take place more than two weeks from now.

However, not all sellers in Mexico were in agreement about the price reductions, and some would put up a fight before accepting lower bids.

"We are not reducing our prices. These movements have be<mark>en confusing</mark> people in the market, and scrap gathering was just beginning to rebound," a large seller said.
