Late-November crude steel output at CISA mills falls sharply

Crude steel production among member mills of the China Iron & Steel Association (CISA) decreased significantly in late November, following an increase in the previous ten-day period, according to data released by the association on Friday December 5.

Output for November 20-30 (compared with October 10-20)

Crude steel: 1.82 million tonnes per day, down by 6.4%
 Hot metal: 1.77 million tpd, down by 1.3%
 Finished steel: 2.08 million tpd, up by 8.1%.

“The decline of the output in both crude steel and hot metal shows that steel producers are cutting their productions due to continued financial losses. The current situation is that the price of steel is decreasing, while raw materials such as iron ore and coking coal prices are relatively steady, which might be the main reason behind their losses,” a Shanghai-based market watcher said.

Fastmarkets assessed the price of [domestic hot-rolled coil, ex-warehouse Eastern China](#), at 3,300-3,310 yuan (\$467-468) per tonne on Friday December 5, down by around 10 yuan per tonne from 3,300-3,320 yuan on December 4.

According to the data from CISA, the total spot market steel inventories of all five major products went down by 380,000 tonnes, or 4.4%.

“The decrease of inventories was basically due to the monthly settlement of the mills, which means that it doesn’t necessary directly reflect the real trend of the demand and sale sides.” the Shanghai-based market watcher added.

Triple-S Steel Holdings makes major investment in European steel distributor

Houston, Texas-based steelmaker Triple-S Steel Holdings (Triple-S) has partnered with Vienna, Austria-headquartered steel trading company The Frankstahl Group to make a significant investment in Zimmer Staal, a leading Northern European heavy steel plate distributor located in Antwerp, Belgium, according to a press release seen by Fastmarkets on Tuesday December 9.

The investment comes in the form of a major injection of equity capital into Zimmer Staal, the statement said.

Zimmer Staal is strategically located in the Port of Antwerp, where it operates a purpose-built warehouse with a permanent stock of approximately 60,000 tonnes of hot-rolled heavy plate. The distributor offers various dimensions and grades of heavy plate, including commercial grades and shipbuilding steels.

Triple-S is one of the largest steel service centers in the US, with over 50 locations across North America and a turnover of over 1,000,000 tonnes annually, offering structural steel, tubing, specialty metals and value-added processing in construction, manufacturing and infrastructure.

The substantial increase in equity will provide the necessary liquidity for Zimmer Staal to achieve its goals for further growth in revenue and product range, while the company's management and workforce will remain unchanged, according to Luc Cools, Zimmer Staal's managing director.

"The entire Zimmer Staal team are extremely pleased about the investment from our new partners. This influx of capital will allow us to accelerate our development plans," Cools said in the statement. "Equally important, however, is that we have found partners who understand our business, offer genuine added value and can support us in our strategic direction. We are thrilled to be working with these two leading international steel groups from Europe and America."

US domestic plate prices stable amid uptick in demand; more price increases expected in near term: sources

Plate prices in the US were steady on Tuesday December 9, with market participants reporting a moderate improvement in demand, and sources anticipating further mill price hikes coming in December or January 2026, following increases in late November.

Fastmarkets' weekly assessment for [steel cut-to-length plate carbon grade, fob mill US](#) was \$51 per hundredweight (\$1,020 per short ton) on Tuesday, steady week on week, but up by 2% from \$50 per cwt on November 18.

Inputs were collected in a range of \$49-51 per cwt, representing offers and assessments of the general spot market.

Demand for domestic plate has risen modestly, sources told Fastmarkets, with some market participants reporting a moderate uptick in demand and spot activity in the final month of the year.

Sources anticipate that mills will increase plate prices in the near term, with the expectation that demand will continue to improve in the first quarter of 2026.

Nucor last announced a plate price hike of \$30 per ton (\$1.50 per cwt) in a letter to customers on [November 24](#).

"We've had a recent uptick in demand, and we're expecting further price increases as we head into 2026," a distributor said. "Scrap is projected to rise as well, and we're optimistic that demand will continue to trend upward. All in all, we're positioned to move good volume going into the new year and [we] are looking forward to a successful 2026."

A second distributor shared a similar view, saying, "We do expect demand to get better as we move through Q1 [of] 2026. Not 'coming out of the gates' strong but getting a little better as we move through [the first quarter]. [There are] rumors of another plate [price] increase by year's end [or] early January [of 2026]."

"Plate demand has been steady in our market for the last few months, [and] we are optimistic that demand will increase in 2026," a buyer said. "We are forecasting [that spot plate prices will be at] \$52.50 per cwt in Q1 [of] 2026."

Lead times were reported at four to six weeks.
